



**AMERICAN INTERNATIONAL ASSURANCE COMPANY, LIMITED**  
**Pursuant to Section 49FC(1)(b) of the Insurance Act, Chapter 142 of Singapore**

Notice is hereby given that a scheme dated 17 August 2011 (the "**Scheme**") to effect the transfer (the "**Transfer**") of the life insurance business and general insurance business of the Singapore Branch of American International Assurance Company, Limited (Hong Kong Company Registration Number 2047, a company incorporated and existing under the laws of Hong Kong ("**AIA**")), to AIA Singapore Private Limited (UEN: 201106386R), a company incorporated under the laws of Singapore with its registered office at AIA Tower, 1 Robinson Road, #13-00, Singapore 048542 ("**ASPL**"), will be submitted to the High Court of the Republic of Singapore (the "**High Court**") for confirmation under the provisions of Section 49FB of the Insurance Act Chapter 142 of Singapore (the "**Insurance Act**"). Following the Transfer, the life insurance business and general insurance business of AIA will vest in ASPL.

**General Nature of the Scheme**

The Scheme will take effect as from 0001 hours (Singapore Time) on 1 January 2012 or such later date as AIA and ASPL may agree in writing and the High Court may allow (the "**Effective Date**").

The Scheme provides for ASPL to acquire, *inter alia*, the business, assets, liabilities, duties and obligations of the life insurance business and general insurance business of AIA, save for the assets and liabilities specifically excluded in the Scheme, as at the Effective Date.

**Effect of the Scheme**

Every person being a holder of a life insurance policy or a general insurance policy of AIA shall on and from the Effective Date become entitled in substitution for any right or rights available to him under such policy or policies against AIA to the same right or rights against ASPL and (as regards policies under which premiums continue to be payable) shall account to ASPL for any further premiums as and when they become due.

**Documents Available for Inspection**

Copies of the Scheme will be available for inspection by all members of AIA and all holders of the life insurance policies or general insurance policies of AIA (who should at the time of the inspection produce evidence that they are such policyholders or members) for a period of fifteen (15) days from the date of publication of this notice during office hours from 9.00 a.m. to 5.30 p.m. at the following addresses:

**Application to High Court**

An application to the High Court for confirmation of the Scheme will be made by AIA and in the course of this application, AIA will be requesting the High Court to dispense with the sending of copies of the Scheme or approved summaries thereof to every policyholder affected by the Scheme pursuant to Section 49FC(3) of the Insurance Act. Any person who in the opinion of the High Court is likely to be affected by the Scheme as a holder of a life insurance policy or a general insurance policy of AIA or otherwise and who is desirous of opposing the making of an Order for the confirmation of the Scheme may appear at the time of hearing of the application (which will be fixed by the High Court at a later date), in which case he is required to give seven (7) clear days' previous notice in writing of his intention so to appear together with the grounds of his objection to the undersigned, the solicitors for AIA.
