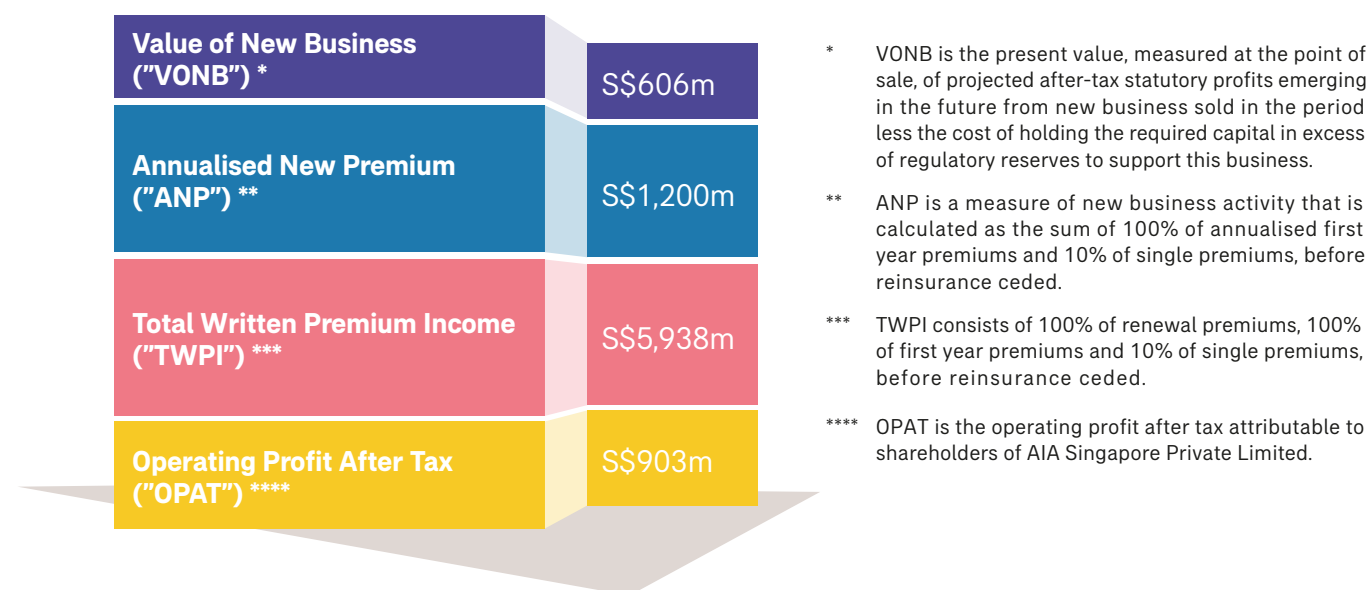


HEALTHIER, LONGER,

The Company, incorporated in Singapore, prepares its financial statements based on the Singapore Financial Reporting Standards ("SFRS"). As a financial institution in Singapore, the Company is regulated by the Monetary Authority of Singapore ("MAS") and operates based on a set of regulatory requirements namely, the Insurance Act and the Insurance Regulations as issued by the regulator. The above are done for the Company's financial year ended 31 December for each year. The Company's annual financial statements can be obtained from <https://www.acra.gov.sg/>

As part of the overall AIA Group (the "AIA Group"), of which the ultimate parent company, AIA Group Limited is incorporated in Hong Kong, the Company also prepares financial information based on International Financial Reporting Standards ("IFRS") and supplementary information for consolidation of results at the AIA Group level. This set of IFRS financial information is prepared based on the AIA Group's financial year ended 31 December.

The Company's financial information based on IFRS Singapore segment and supplementary information for the financial year ended 31 December 2024 are as follows.



The above financial measures do not have standardised definitions within the accounting standards made or formulated by the Accounting Standards Committee, any regulations, notices or directions that are issued under the Insurance Act, or any codes, guidelines, policy statements or practice notes that are issued by the MAS. Hence, the disclosure may not be comparable with the disclosures made by other insurers.

Life fund is the major profit contributor, and account for more than 99% of IFRS operating profit after tax. The remaining IFRS operating profit after tax is contributed from the General fund.
