## Does your dog qualify for coverage?

- Your dog must be between 3 months and 7 years of age at point of application
- This plan provides coverage for dogs up to 8 years of age
- Covers all breeds of dogs, except mastiff, bull terrier, Staffordshire bull terrier, pit bull terrier, American pit bull terrier, Argentina dog, Canary dog, American bulldog or dogs crossed with any of these breeds and/or wolves. Your dog need not be a pedigree to qualify
- You must be the dog's owner
- Your dog must be licensed
- Maximum of 1 policy for each dog you own, up to a maximum of 2 dogs per household

### General Note:

There are certain conditions, such as pre-existing conditions and congenital defects, for which no benefits will be payable. This plan only covers for loss / damages, injuries and treatments in Singapore. Please refer to the policy contract for the full list of exclusions.
